- 1. Meeting called to order by Tim Candahl at 5:00 p.m.
- 2. <u>Approve Minutes.</u> Motion by Knutson to approve minutes from 5/21/2024, second by Heal. Motion carried unanimously.
- 3. <u>Bills Payable.</u> Discussion ensued. Motion by Heal to approve open invoices for \$36,133.76, second by Padesky. Motion carried unanimously. Motion by Knutson to approve closed invoices for \$30,141.56, second by Padesky. Motion carried unanimously.
- 4. <u>Public Comment</u>. Stacey Klein introduced herself, running for Senate. Tim Betlach, following up on neighbors with 3 dogs.
- Breidel Coulee Bridge Design Proposal. Discussion ensued. Motion by Ehler, to approve CBS Squared to move forward with the project, second by Padesky. Motion carried unanimously.
- 6. <u>Boma Road West Bid Award</u>. Bernie from CBS Squared presented bids and recommendation. Motion by Ehler, to approve the low bid from Strupp with option A, for a total of \$450,725.35, second by Padesky. Motion carried unanimously.
- 7. Annexation Petition (11-2003-0) Guadalupe Shrine. Discussion ensued. No action.
- 8. <u>Hwy 14/61 Sidewalk-Design Contract and State/Municipal Agreement (SMA)</u>. Discussion ensued. Peterson updated the board on the project. Bernie from CBS Squared provided information as well. Motion by Padesky to approve the design, contract and SMA. Second by Heal. Motion carried unanimously.
- 9. Administrator/ Public Works Report.
